# Healthcare Information Technology Services Physician Equipment Procurement Using CME & PEF Funds

#### November 2021

Department Administrators have two options when purchasing new hardware/software for Physicians using CME/PEF funding:

## 1. Procurement through UKHS – Recommended Option

- Equipment is ordered through a department administrator on behalf of the physician (using the department administrator's Hospital cost center, not UKP's cost center)
- Department administrator must contact the UKP accountant for reimbursement. Physicians are responsible for sales tax if PEF-funded.
- Use MyIT self-service to make a purchase request
  - o <u>MyIT Hardware Request</u>
  - o <u>MyIT Software Request</u>
- HITS is responsible for procuring, deploying, and managing the equipment (including the operating system, patches, security, software installations, and hardware support)

## 2. Procurement outside UKHS (Physician Purchased)

- UKHS will support Citrix access to health system resources
- Limited access to local hospital resources (No local access to resources or VPN)
- Support for software installations is limited due to licensing and compliance restrictions

   Exceptions: Citrix, Microsoft 365, Teams, Zoom
- HITS recommends an extended warranty of at least three years as well as accidental damage/loss/theft coverage via manufacturer or physician's personal insurance company

#### The following guidelines apply to all purchases:

(consult UKP Professional Expense Reimbursement Policy for further detail)

- Devices are allowed based upon departmental policy, but must be for physician use in work-related activities
- Items cannot exceed \$2,500 in value without department chair approval
- Physicians should reference their contract as well as UKP policies regarding reimbursement and frequency limitations for purchases
- Items may be taxable to the employee depending on applicable IRS regulations and on-going ownership of the device, please reference UKP policy for details
- Department chairs may approve additional devices for an employee when the device is used in providing clinical care
- Computer accessories, software, monthly charges, warranties, and reasonable repairs are allowed
- University software licenses cannot be included on UKHS hardware
