Occupational Health Pre-Boarding / Post-Offer Visit

Welcome and we look forward to meeting and caring for you!

The University of Kansas Health System is committed to providing and conserving a safe and healthy environment for all its teammates, those we care for, and our communities. Safety and health protection measures are initiated during the health system pre-boarding (post-offer) process, which includes an Occupational Health *examination visit.

The health system is also committed to offering the best pre-boarding experience as much as possible. To demonstrate this, the health system is offering you the below guidelines to follow before your Occupational Health examination visit.

Before Scheduling an Occupational Health Examination Visit

- ❖ Form completion. To reduce Occupational Health visit time, print and complete the Medical History and OSHA Respiratory Protection Questionnaire forms. When you fill out the forms, please be sure to complete each form field and question. If you answer a question “yes,” please give a brief explanation. Then, bring each completed form with you to your Occupational Health visit.
- ❖ CDC and OSHA recommendations and regulations as well as UKHS policy for Immunization, Immunity, and Tuberculosis (TB) Testing and Surveillance Records. Provide the following childhood through adult records upon your arrival for the Occupational Health visit.
 - Official vaccination and/or immunity testing records for: Hepatitis B; Measles, Mumps, and Rubella (MMR); Tetanus, Diphtheria, Pertussis (Tdap; at least one vaccination since 2005) and Tetanus, Diphtheria (Td); Varicella (chickenpox); and, Seasonal Influenza (current season/year) vaccination.
 - TB testing and/or past-positive TB testing records. If you have a past-positive TB testing history, please submit all documentation available (e.g. positive results, provider follow-up visits, 2-view chest x-ray records, medication treatment completed, etc.).

Occupational Health Examination Visit

- ❖ Arrive to the visit early. Please allow at least one hour for the visit. The visit time has the potential to be reduced by printing, completing, and providing the forms upon your visit arrival.
- ❖ Drink water and eat before your visit, as this will help you prepare for a blood sample to be collected and potentially receive an immunization(s).
- ❖ Your vision will be screened (i.e. near, far, and color vision). Please wear or bring corrective lenses, as needed.
- ❖ Please do not bring children to the visit with you.
- ❖ If you have any questions or concerns, please contact the UKHS Occupational Health clinic.
